Reference is made to the (i) joint announcement of Easyknit Enterprises Holdings Limited (“EE”) and Easyknit International Holdings Limited (“EI”) dated 16 January 2014 (the “**Joint Announcement**”); and (ii) the announcement issued by EE dated 7 March 2014 regarding the results of the SGM held on the same day. Unless the context requires otherwise, capitalised terms used herein shall have the same meanings as those defined in the Joint Announcement.

Pursuant to the terms of the Subscription Agreement, completion of the Subscription Agreement (“**Completion**”) was intended to take place on or before 17 March 2014, being the second Business Day after the fulfillment of all conditions precedent of the Subscription Agreements.

All conditions precedent of the Subscription Agreement were fulfilled on 13 March 2014. Upon the Completion, EE will cease to be an associate of EI and will be accounted for as a subsidiary of EI as from that date. Accordingly, EE's assets, liabilities, cash flows and results will be consolidated into the consolidated financial statements of EI upon the Completion. Having considered the proximity of the initial date of Completion (17 March 2014) to the yearend date of both EE and EI's annual financial statements (31 March 2014), the EE Directors and EI Directors agree and announce that Completion will be deferred to on or before 31 March 2014.

Save for the above, the terms and conditions of the Subscription Agreement remain unchanged in all respects. EE and EI will make further announcements to update shareholders as to the status of Completion as and when appropriate.
